- Application processing fee of **Rs. 1,000/-** only (Non-refundable) be deposited in online University **Main Account No. 1029004167340870, Extension and Development of Bolan University of Medical and Health Sciences (BUMHS), National Bank of Pakistan, Staff College, Quetta** or Demand Draft in the name of BUMHS. The deposit slip must be attached with the application form.

IMPORTANT NOTE

- The Scholarships will be awarded in specific subject areas. For details about subject areas, selection criteria and complete terms & conditions of the Scholarship please visit BUMHS website <http://www.bumhs.edu.pk>.
- TA/DA will not be permissible for the purpose of interview.
- Shortlisted candidates who are not faculty members of BUMHS, Quetta will have to compete for the faculty position as Lecturer/ Assistant Professor in the University through its selection board. Scholarship will only be awarded against the respective faculty position.
- In-service applicants and faculty members from other universities will also go through the same selection procedure as explained above in case they are considered for award of scholarship.
- Faculty members, both the existing and newly inducted, are required to complete all the admission requirements of the scholarship by the notified deadlines.
- Award of scholarship will only be confirmed after faculty appointment and grant of study leave as per rules of the BUMHS, Quetta.
- Successful scholars will be appointed without pay & allowances till completion of their studies. The emoluments will start once they join the BUMHS, Quetta after successful completion of their studies abroad and submission of the degree in the field of award.
- Scholars availing the scholarships are required to execute a Security bond, that they shall serve BUMHS, Quetta for a period of five years after completion of studies abroad or will return the scholarship money including penalty amount as per HEC rules.
- No request for change of university for the purpose of service bond will be entertained at any stage.

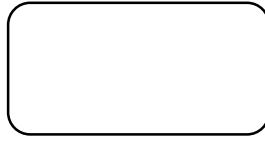

The following are the terms & conditions for the Award of Scholarship and the acceptance of the award is an acknowledgement of these obligations:

1. An awardee/Scholar shall not change the course of study specified in the letter of award without obtaining prior approval of the Vice Chancellor Bolan University of Medical and Health Sciences Quetta.
2. An awardee/Scholar is not to hold any other scholarship/stipend during the scholarship period of his/her study.
3. A change of University/Institute during the study shall only be admissible with the prior approval of the Vice Chancellor Bolan University of Medical and Health Sciences Quetta.
4. An awardee/Scholar is required to execute a bond with the Bolan University of Medical and Health Sciences that he/ she shall serve BUMHS for 5 years subsequent to the award of the Degree.
5. An awardee/Scholar shall sign an agreement with the Bolan University of Medical and Health Sciences(BUMHS) on non-judicial (stamp) paper to the effect that in case the awardee/Scholar fails to complete his/her study, he/she shall refund to the BUMHS the total amount spent on his/her studies by the BUMHS. (Format enclosed).
6. Personal guarantee of a person of means shall be provided on Non-Judicial (stamp) paper (Format enclosed).
7. Every document i.e. Deed of Agreement, Guarantee to BUMHS and Certification of Financial Soundness must be properly notarized, that means the document must be attested by Notary public and the same be registered in Notary register maintained by Notary public and the signatures of the executants must be obtained on the register and the number of the registration must be mentioned along with the notarial stamp.

**DEED OF AGREEMENT FOR UNDERTAKING A COURSE OF STUDIES
SCHOLARSHIP UNDER (OVERSEAS SCHOLARSHIP SCHEME FOR PhD IN
SELECTED FIELDS)**

This agreement is made, on the day of 2020, between

- 1) Mr. / Ms.son / daughter of
..... hereby called the Scholar, and
- 2) Bolan University of Medical and Health Sciences(BUMHS) through the authorized officer
in the BUMHS, hereinafter called the BUMHS.

WHEREAS Mr. / Ms. has been selected by the BUMHS for the award of Scholarship for PhD studies under the Scheme “Human Resources Requirements” and the scholar has agreed to accept the same on the terms and conditions governing this scholarship award.

Now this deed witnesses as under:

- i) This scholarship award is initially valid for a period of one year and would be extendable periodically to a maximum of **4 years PhD** subject to the satisfactory performance of Scholar. 5th year extension shall be subject to recommendation of supervisor with subsequent approval of the University authorities.
- ii) The payment of allowances admissible under the scholarship program shall be made subject to the complete adherence to all rules and regulations governing the scholarship program as well as satisfactory performance in the authorized studies.
- iii) The scholar shall not change the specified course of studies nor register himself/herself for any other course or program without prior approval of the BUMHS.
- iv) The scholar shall not extend the specified period of studies without prior approval of the BUMHS.
- v) The scholar shall not undertake employment whether paid or otherwise or join any clinical course or service including appearing in the plab test or any other professional service without approval of the BUMHS during his/her course of studies abroad or otherwise.
- vi) The scholar shall refrain from engaging himself/herself in any political, commercial or any other **activity** incompatible with his/her program of studies abroad.
- vii) In case the scholar fails to qualify the course for which he/she was awarded Scholarship, the BUMHS reserves the right to recover entire expenditure inclusive of travel cost from the Scholars/Guarantor.
- viii) The scholar shall return to Pakistan immediately after the completion of the approved

course for which he/she was sent abroad, and shall serve in BUMHS for a period of **five years** as may be prescribed.

- ix) The scholar shall **not incur any debts** during his/her stay abroad and will clear all outstanding bills before leaving the country of study/training/research.
- x) The scholar shall regularly submit the quarterly / six monthly progress reports on his/her assigned Program through the academic supervisor abroad to the Bolan University of Medical and Health Sciences and a final comprehensive report immediately on completion of the study/training/research.
- xi) The scholar shall report to the University authorities after his/her return to Pakistan for joining service/posting.
- xii) The scholar shall be liable to disciplinary action as follows:
 - a) If he/she fails **to** avail of the award without any cogent reason acceptable to BUMHS he/she **shall be** debarred from further study/training/research abroad under any Scholarship Program. If any financial loss is sustained as a result of his/her failing thus to avail the award, he/she **shall be held** responsible therefore and liable to make the loss good, apart from being liable to any penalty to be imposed by the BUMHS in this behalf.
 - b) If he/she fails to comply with the instructions/orders of BUMHS for proceeding abroad without any cogent reason acceptable to BUMHS, he/she **shall be liable** to reimburse to the University, on demand, the amount of passage money spent either by the country to be visited or BUMHS or both, in connection with his/her scheduled visit abroad.
 - c) If he/she fails to obey or act in accordance with BUMHS's order directing him/her to return to Pakistan, he/she **shall be liable** to action under the acts/rules in force in Pakistan impounding or confiscating passports.
 - d) If he/she violates any condition laid down in the Bond for Studies/training abroad under the Scholarships Program, he/she will be liable to pay the penalty as prescribed therein.
- xiii) The scholar is liable to disqualification from foreign training or such other disciplinary action as BUMHS may consider appropriate, if:
 - i) He / she violates any of the foregoing conditions, or
 - ii) He / she **is** found to have made any misstatement therein before.

AND THE SCHOLAR FURTHER COVENANTS, that in case of breach of any of the above terms and conditions as well as the rules / terms and conditions those governing scholarship award and / or his / her failure to return to and serve in Pakistan as directed by the BUMHS for the specified period, the scholar **shall be bound** to pay the BUMHS a penalty as prescribed by the BUMHS besides compensate the BUMHS by making a **refund of the total amount** of expenditure including travel cost incurred on him / her in Pakistan Rupees and in foreign currency or its equivalent in Pakistan Rupees at the official rate of exchange prevalent on the date of the breach of the above agreement. The amount of penalty and the compensation as prescribed and assessed by the BUMHS shall be final and conclusive. IN WITNESS WHEREOF, the parties aforementioned have signed this deed in token of acceptance thereof.
