5. He/She is directed to deposit Admission/1st Semester fee Rs.75,000/- (for General Seat) within seven days of the issuance of this letter. After the expiry of the above time period fee will not be deposited and the candidate will not be eligible to claim the admission.
6. The Candidate shall submit verified copies of his/her Educational documents duly verified from the issuing Boards / authorities within fifteen days of the issuance of this letter.
7. Students are required to wear prescribed uniform. He/She must observe policy of wearing uniform strictly as Student and without uniform He/She will not be allowed inside the classes, lecture halls, etc.
8. In case candidate fail to carry out the above instructions, His/Her admission will be cancelled automatically without any notice.


